

## MONTGOMERY COUNTY FISCAL COURT COVID-19 PANDEMIC SMALL BUSINESS RELIEF PROGRAM

In light of the COVID-19 Pandemic currently affecting our County, the Montgomery County Fiscal Court recognizes the increased burden being placed on local businesses. The Montgomery County Fiscal Court wishes to pledge additional support by offering business relief grants of up to \$1,000 for small businesses to aid in recovery of their operations.

To be eligible for assistance, a business must meet all the following:

- 1. Exist within the County limits in a brick-and-mortar location.
- 2. Own the property/building or have a lease arrangement with the property owner.
- 3. Be current on Montgomery County property tax payments; have reported all Payroll and Net Profits taxes to the Montgomery County Tax Administrator; and has met all requirements mandated by the Secretary of State to operate in the State of Kentucky.
- 4. Be a small business as defined as:
  - a. Net profit income for 2019 of no more than \$100,000 or businesses with less than 10 employees, supported by the presentation with application with your Business Tax Return, K-1 and/or Schedule C (Form1040).
  - b. Open and operating before March 13, 2020, or newly opened and operating after that date and subject to full or partial closure due to Executive Order.
- 5. Not be a franchise or franchise affiliated.
- 6. Be categorized as a non-essential business type that was required to cease or significantly reduce operations as a result of the Executive Orders issued by the Governor and has been compliant with this order.
- 7. Business must be listed in the eligible business category and still in operation.

#### SCHEDULE OF ASSISTANCE

- This relief program grant will be awarded to qualified businesses only.
- The maximum amount of funding assistance will be \$1,000 for a Full Time Business, and \$400 for a Part Time Business. Priority will be given to Full Time Businesses.
- Assistance will be provided to businesses after review of their application.
- Applications will be accepted January 20, 2021 through February 10, 2021.
- Funds will be awarded beginning February 16, 2021.
- Recovery funds will be awarded to successful applicants for paid expenses that have occurred beginning March 13, 2020 and during a period of a mandated shutdown or closure. Proof of these payments will be required. Limited Recovery Funds (no more than \$700) are also available for those Full Time Businesses who opened their business after March 13, 2020 and have also experienced a mandated shutdown or reduced operations after opening as a result of the Executive Orders issued by the Governor and has been compliant with this order.

#### **SUBMISSION OF APPLICATION**

An application for funds must be completed and submitted to the Montgomery County Fiscal Court-Annex Building by the close of business (4:00 PM), February 10, 2021. Businesses most significantly impacted by the Executive Orders of the Governor are encouraged to apply.

#### **FUNDING CRITERIA**

#### Eligible Businesses:

- 1. Retail (general, specialty)
- 2. Barber/Beauty Salons
- 3. Restaurants
- 4. Small businesses closed by Governor's Executive Order

#### **Non**-Eligible Businesses:

- 1. Home Occupations
- 2. Real Estate Companies/Agents
- 3. Attorneys
- 4. Finance/Accounting/Bookkeeping/Tax Firms
- 5. Food Trucks
- 6. Not-for-profit organizations
- 7. Landlords/rental property owners

#### Eligible Expenditures:

- 1. Payroll
- 2. Rent/Lease/Mortgage Payments
- 3. Utilities

The applicant will be notified if funding will be provided, the amount of funding if approved, and will be required to provide an IRS W-9 Form to the Montgomery County Fiscal Court. For consideration, applicants are required to submit receipts for payment of Eligible Expenditures and their Business Tax Return, K-1 and/or Schedule C (Form1040) with their applications.

The Montgomery County Fiscal Court is pledging additional support to small businesses forced to close or reduce services in response to COVID-19 related Executive Orders issued by the Commonwealth of Kentucky. The County is offering a one-time business relief grant up to \$1,000 for eligible businesses within the County boundaries of Mount Sterling. Businesses most significantly impacted by the Governor's Executive Orders closing non-essential businesses in early 2020 are encouraged to apply. <u>IMPORTANT INSTRUCTIONS AND INFORMATION</u> - Complete all parts of this application and provide required documentation and mail to: Montgomery County Fiscal Court- Annex Building, 44 West Main Street, Mount Sterling, KY 40353 Attention: RELIEF. – Applications may also be placed in a sealed envelope (marked RELIEF) and dropped off at the Montgomery County Fiscal Court – Annex Building.

Incomplete applications will not be considered. Funds are limited and grants will only be made as long as funds are available. Full Time Businesses have priority over Part Time Businesses. Businesses are <a href="https://high.ncouraged">highly encouraged</a> to submit copies of all receipts for re-imbursement with this application. Requests for additional information may be required for grant awardees.

Completion of this application does not guarantee an award. Funds will be awarded beginning February 16, 2021.

To be eligible to apply for this grant, a business must:

- 1. Be categorized as a non-essential business type that was required to cease or reduce operations as a result of Executive orders issued by the Governor of Kentucky and has been compliant with said order.
- 2. Currently exist within the County limits of Montgomery County in a brick and mortar location.
- 3. Own the property or have a lease agreement with the property owner.
- 4. Must be current on all County taxes and fees and Occupational Taxes due to Montgomery County.
- 5. Be open and operating before March 13, 2020 or have opened after that date and been mandated to cease or significantly reduce operations after date business opened.
- 6. Have a Net Profit for 2019 of no more than \$100,000 or a business with less than 10 employees.
- 7. Not be a franchise or franchise affiliated.
- 8. Business must be listed in the eligible business category of the program overview.
